Federal income tax return (if filed, Form 1040, 1040A, 1040 EZ, Telefile Worksheets), Social Security Form SSA-1099, Pension and Annuities Form 1099-R, and other income documents. Also, bring documentation of deductible out-of-pocket medical expenses, including Medicare and supplemental-health-insurance premiums, payments to doctors and other licensed medical practitioners, medical-equipment purchases, prescription drugs, etc.

If you do not bring your income and out-of-pocket medical-expense information, we will not be able to help you complete the exemption form.
